1938, Apr 1 Letter: McDermott to Walker

- Re: Give O'Daniel the keys to the Archives, as well as some stocks & funds that he desires. When he sees Walker, he will share with him what "the Master General remarked in regard to the House of Studies."
- 1938, Apr 9 Letter: Walker to McDermott
 - Re: "keys, stocks, and funds" have been turned over to O'Daniel. According to your instructions at the time of visitation, Walker has made a duplicate set of keys.
 - Hand written notes on typed copy:
 - #1 –" Master General in Washington from Manila Mar 19; in New York Mar 22ff; sailed for France – Mar 30."
 - #2 "Vic returned to the <u>fold</u>, after sit-down strike of 15 months (1/17/37 4/9/38). Returned to Archives too. The deal – my head."

- Re: W/to what might be in the Archives relative to St. Peter's, Memphis. Bernard gives a general overview but is very guarded in his reply, e.g.,
 - "You know something of the situation here, but not all; and I do not think the situation should be put in writing."
 - He suggests turning "your letter over to Father Coffey who is acting assistant."
 - "I hope you can guess enough to let the information come to you from a source other than yours truly."
 - "Trust me until we meet, when I shall explain more fully."

Matters w/to the "Cloister Chronicles" in the December 1937 issue of Dominicana:

- #1 1938, Nov 26 Letter: McDermott to Walker
 - Re: The text of the "Cloister Chronicles" had been sent to McDermott for 'proofing." McDermott raises a number of technical matters (e.g., consistency in titles) & makes corrections .
- #2 1938, Nov 28 Letter: Walker to McDermott
 - Re: Walker explains what had happened. He had not read them his appointment of censor had expired.
- #3 1938, Dec 4 Letter: McDermott to Walker
 - Re: Thanks Walker for his explanation. McDermott appoints him "as one of the Censors of *Dominicana*" & asks him to suggest another to assist him.
- #4 1938, Dec 10 Letter: Walker to McDermott
 - Re: Walker has communicated McDermott's corrections, etc., to Fr. Luke Thornton. He agrees with McDermott's idea of what the "Cloister Chronicles" in *Dominicana* should be. He suggests Fr. Thornton as the second Censor.
- 1938, Dec 6 Letter: McDermott to Walker
 - Re: McDermott sends stipends to Washington, but wonders "just what effort is being made on the part of your Community to collect stipends."
 - 1938, Dec 10 Letter: Walker to McDermott (3pp.)
 - Walker provides abundant detail to support the efforts of the Washington-DHOS community to obtain stipends & fulfill them. There seems to be a decrease in stipends in the area according to local pastors. The number of priests residing at Washington has increased substantially in recent years 1935-36 = 46; 1938-39 = 75.
 - Photostats of Provincial financial report for 1936, 1937 & 1938 to provide data on donations from St. Pius to Province of St. Joseph.
- 1939, Jan 13 Letter: Walker to McDermott
 - Re: "response to your telegram for full information about our laybrothers here.
 - Outlines what is being done w/to religious life formation.
 - Comments upon 4 laybrothers who are troublesome all in simple vows: Angus McParland, Raymond Delaney, Vincent Connell, Joseph McInnis
 - 1939, Jan 18 Letter: McDermott to Walker
 - McDermott does not understand why "it is so difficult to handle Lay-Brothers in any community." He re-assigns Angus McPartland (sic) & Raymond Delaney. At the moment he does not have a laybrother to send Washington. He will take this up at visitation in a few weeks.
- 1939, Jan 27 Letter: Walker to McDermott
 - Re: "Chaplaincy of the Jail" "it is desirable, if not necessary, to 'break in' Father McGowan before releasing Father Nuttall" → reasons for this.
 - 1939, Jan 31 Letter: McDermott to Walker
 - Re: He will take this up at visitation "during the latter part of the week."

11 April 2025

1939, Feb 4 Letter: Walker to McDermott

- Re: A letter received from the Apostolic Delegation by way of Fr. Daly w/to some work that Fr. McMahon has done for the delegation how should Walker respond?
 - 1939, Feb 7 Letter: McDermott to Walker
 - Tell the Delegate that Fr. McMahon is being transferred to New Have, but there is no reason why he cannot continue to do work for the delegation.
 - Copy of a Letter: Walker to John Berchmans Affleck ["Berky"], prior at New Haven, forwarding McMahon's mandamus to him.
 - o 1939, Feb 18 Letter: McDermott to Walker
 - The Apostolic Delegate has requested that McDermott not transfer McMahon to New Haven that he might continue to assist the Delegate. He will comply with the Delegate's request. But, forward the mandamus to Fr. Affleck. He will allow McMahon to remain in Washington until his work is complete. However, he is relieving him of the office of Procurator. Father McCadden will assume this office.
 - 1939, Feb 21 Letter: Walker to McDermott
 - Acknowledges letter of 18 Feb 1939 all has been done as McDermott wishes.
- 1939, Apr 1 Letter: Walker to Thomas Garde, Socius to Master of the Order
 - Re: Walker asks that Garde (who was in the process of visiting several convents of the Province), if he intends to visit Washington-DHOS, to carry out a "thorough investigation" of his election in January 1937.
 - On the day of his election one vocal accused Walker of having "shenaniganed" the election [from Walker's description the unnamed vocal is Fr. O'Daniel DFW]
 - Within the past two months the Provincial has accused another vocal [Fr. McMahon DFW] of having "engineered" Walker's election & of creating "a bad spirit in the community" for which he was relieved of a position to which Fr. McDermott had appointed him on 17 Oct 1938 [Procurator] & whom Fr. McDermott has recently transferred from Washington.
 - Walker suggests that his removal as Archivist in the Provincial Chapter of 1938 was probably the work of his unnamed accuser [Fr. O'Daniel DFW].
 - Attached: handwritten notes of Walker's listing items that might support his request for an investigation.

11 April 2025

1939, Apr 21 Letter: Walker to McDermott

- Re: Walker has become aware that there are two in the formation community who are illegitimate. Fr. Johannsen assured him that dispensations had been granted & are in their personal files at the provincial office. Walker asks that someone check to make sure, for the two should have received a document granting the dispensation, but apparently neither had received one. If there are no documents, Walker would be glad to prepare a petition to the Master of the Order for a dispensation.
 - 1939, May 3 Letter: McDermott to Walker
 - Re: There are no documents. Prepare a petition.
 - 1939, Dec 10 Letter: Walker to McDermott
 - The matter had slipped his mind. He encloses the petitions (which are not in this file).

1939, Apr 23 Letter: Walker to Thomas Garde, OP

- Re: Walker recalls their conversation about the popularity of "novenas" in the USA. He sends Garde a sample of the typical literature that circulates in the USA.

- #1 1939, Apr 24 Letter: Fr. Canice Mooney, OFM (Librarian at the Franciscan Friary, Dublin) to Walker
 - Re: Responds to an earlier inquiry of Walker about documents relating to Thomas Carbry, OP
- #2 1939, May 4 Letter: Walker to Fr. Canice Mooney, OFM (2pp)
 - Re: Walker outlines possible documents in which he would be interested.
- #3 1939, St. Paschal [May 17] Letter: Fr. Canice Mooney, OFM, to Walker (3pp)
 - Re: Fr. Mooney is sending some photostats of documents.
- #4 1939, Jun 7 Letter: Walker to Fr. Canice Mooney, OFM

1939, May 3 Letter: Walker to McDermott

- Re: Walker reports an automobile incident involving 3 Friars a professor & 2 student priests from the Preachers' Institute FYI.
- 1939, Jun 1 Letter: McDermott to Walker
 - Re: McDermott wishes to know "what action you have taken" & by whose authority a professor took two students from the Preachers Institute w/o the permission of the Prior. The 3 had to appear in traffic court.
- 1939, Jun 4 Letter: Walker to McDermott
 - RE: Because the three were manifestly contrite & expressed voluntarily their readiness to accept any penance he might impose, he "felt that kindness would produce more lasting good than severity" he did not impose a penance.

Handwritten notes of Walker (1p):

- Garde has been in River Forest; left there 5/21/39.
- [Unclear reference]: "Spl. Delivery 5/25/39"
 - [from other notes, I surmise that Garde had requested a copy of a 1938 financial report
 probably the Province, but perhaps of River Forest? DFW]

1939, Sep 7 Letter: McDermott to Walker

- Re: Mrs. Elizabeth Ledig has contacted McDermott w/to a cruise to South America. If Walker can arrange to take this trip, McDermott gives permission & would also see to finances if this is necessary.
- 1939, Sep 10 Letter: Walker to McDermott
 - Re: Bernard decides that he really needs to spend some time with his 86-year old mother in October, if McDermott approves. He appreciates McDermott's gesture.

1939, Sep 27 Letter: Walker to McDermott

Re: There is more trouble between two COOP brothers – Luke Barnes & Vincent Connell, both in simple vows. Luke Barnes has been extremely nervous for "more than a year" with headaches, etc. – doctors have suggested "he be psychoanalyzed." Walker suggests that Vincent Connell is the source of the difficulty. If McDermott sees fit to move Bro. Vincent to another house, Washington will make do.

11 April 2025

Matters regarding the Preachers Institute & a few others:

- #1 1939, Oct 4 Letter: McDermott to Walker.
 - Re: McDermott asks that, in order to give the student priests in the Preachers Institute experience, Walker give preference to them in assigning week-end work. He further asks that he consult Fr. Bonniwell, director of the Institute, before assigning them, as Bonniwell would know when these student priests were prepared "to deliver a Sunday instruction."
- #2 1939, Oct 6 Letter: Walker to McDermott (3pp)
 - Re: W/to "preference in assigning student priests" he makes 3 points:
 - 1. That is already his policy he elaborates;
 - 2. He had contacted Fr. Bonniwell in the past, but he was absolutely opposed to using student priests in this way; Bonniwell would not relent & so Bernard told him he considered Bonniwell's opposition "illegitimate and illegal" & that he would continue to assign them;
 - Bonniwell has opposed assigning student priests to other opportunities, e.g., "40 Hours," and insists that they write weekly sermons on the Gospel & Epistle each week and that they have no time to do anything else.
 - Bonniwell apparently continued to be a problem. Walker continued to assign student priests as he saw fit.
- #3 1939, Oct 11 Letter: McDermott to Walker (2pp)
 - Re: McDermott supports Walker's approach to assigning week-end work. He also notes some typographical inconsistencies in the latest issue of *Dominicana*.
- #4 1939, Oct 10 Letter:

- Re: Problems with Bonniwell continue. He asks McDermott to make a decision on 2 points:
- 1. Are the Prior's assignments "subject to the veto of the Director of the Preachers Institute?"
- 2. Is the Preachers Institute independent of the Regent of Studies "who has been charged with the direction of all the studies of the Province?"

• Re: #1 - In no way was it his intention to abrogate the authority of the Prior in regard to the assignments of Fathers. He merely wished to recommend consideration of students of the Preachers Institute.

#2 – He wants well-prepared preachers. When you have an opportunity to come to New York we can take the matter of the Institute and settle any misunderstandings.

- #6 1939, Oct 24 Letter:
 - Re: Walker agrees "with your ideas about the Institute." There are still some items that need definition. He will be happy to come to New York to discuss them.

Matters w/to times for Recreation for Student Priests & Student Brothers

- #1 Memorandum of Prior's side of controversy concerning recreation for student priests and professed students at the House of Studies, Washington. (2pp)
 - RE: Bernard's history (Fall 1937 to Fall 1939) of the problem.
- #2 1939, Sep 26 Letter: McDermott to Walker
 - Re: McDermott imposes rules concerning recreational facilities at DHOS.
- #3 1939, Sep 29 Letter: Walker to McDermott
 - Re: Walker thought McDermott had agreed with his regulations & therefore he posted them. McDermott's regulations, apparently after consultation with Fr. Thornton, now differ. They exclude all those in the community who are not student priests or student brothers (60 in number).
- #4 1939, Oct 3 Letter: McDermott to Walker
 - Re: He appreciates the challenge of satisfying everyone, however, since the student brothers "have not the same freedom as the young Fathers and professors have, these Novices [student brothers] should receive consideration first."
- #5 1939, Oct 6 Letter: Walker to McDermott
 - Re: Fr. Thornton & Fr. Walker have discovered that part of the difficulty about recreational activities resulted a misunderstanding concerning with each was talking about. They have worked everything out. They have a suggested amendment for regulation #4.

1939, Dec 9 Letter: McDermott to Walker

- Re: McDermott is willing to grant Fr. Coffey's request for an extended "quies" provided he also has Bernard's permission. Bernard can grant all the Fathers the usual 'quies".
- 1939, Dec 12 Letter: Walker to McDermott
 - Re: He is happy Bro. Giles Waskowski will be assigned to Washington. He outlines a history of his dealings with Fr. Coffey they seem not to have gotten along well. His proposal is that Fr. Coffey be granted a quies from the close of the University (Dec 20, 1939) until it opens again (Jan 4, 1940) & that Bernard tell him "on my own that he is denied a longer quies because of unsatisfactory work at the University; and that in future he will first seek permission of local authority before approaching his Major superior."
- 1939, Dec 14 Letter: McDermott to Walker
 - Re: Walker's proposal in dealing with Fr. Coffey meets with McDermott's approval; McDermott will back him up.
